I came across this information and wanted to share it with you and your family and friends. Being prepared can make all the difference and give you peace of mind.

**Disasters and your finances**

Whether you live in a hurricane prone area of the U.S., a flood-ravaged or tornado battered section of the country, or a region known for wildfires and earthquakes, there are four key ways you can build a financial fortress around you that will prove invaluable if disaster strikes.

**Make Sure Your Home Is Adequately Insured**

Insurance experts say it is vital for homeowners to review their home insurance policies annually to be sure coverage is sufficient to completely replace, rebuild or repair their homes in the event of a catastrophe. Insurance companies state that most people in the U.S. are vastly under-insured. Don't rely on estimates or suggestions from your insurance agent or realtor alone. Get a local home contractor to come out and provide a detailed analysis of the cost to rebuild your residence if it were completely wiped out. Most homeowner's policies are "replacement cost" policies, and are based on the cost to rebuild your home from the ground up in its current condition. Local contractors or builders know rebuilding information since they're familiar with labor costs, construction materials and prices of various home finishes, such as tile versus carpet, Corian countertops compared to Granite. An alternative to dealing with a contractor, for \$7.95 you can use an online tool offered by AccuCoverage, (<http://www.accucoverage.com>). An AccuCoverage report will calculate the replacement cost of your house based on factors like your home style, its features and the materials used in it. Many insurance professionals use a tool like this to calculate replacement costs. A tornado is considered to be a "wind event" and is generally covered under most homeowner's insurance policies. Other disasters such as earthquakes, floods, landslides and natural fires are generally not covered by homeowners insurance. For protection against these disasters, you must buy separate catastrophic coverage. The federal government underwrites flood insurance. The maximum coverage amount you can get is \$250,000 and prices vary from about

\$350 annually in low risk areas to more than \$2600 a year in high risk zones. The cost of insurance can really add up, but not being insured can be financially devastating.

### **Document Your Valuables**

An important way to prepare for a disaster is to photograph or videotape the contents of your home, especially any expensive items you own. Make a record of what's in your garage or outdoor shed as well. Documented proof of household items makes things easier when dealing with your insurance company. That goes for both homeowners and renters insurance. Photographic records can also help for tax purposes, aiding in proving the market value of items for casualty loss claims. Check out IRS publication 584, a disaster loss workbook that can help create a room-by-room list of your belongings. Also read IRS Publication 547 to learn tax rules for casualties and disasters.

### **Safeguard Financial Paperwork and Photos**

Knowing where your key documents are located is a smart idea any time, but in an emergency situation you may only have 10 -15 minutes notice before you have to evacuate or take cover due to a natural disaster. It is critical to be able to easily put your hands on important paperwork.

### **Create a Backup Set of Records Electronically**

As well as any physical records and photos you store in your home the IRS recommends you keep a backup set of records in a safe place, away from the original set. A backup set of records can be done easily online. Many financial institutions provide statements and documents electronically. Scan photos and paper documents to create electronic copies. You can use third party services to securely store sensitive data away from your home. Doing so means your paperwork and photos won't be lost if a catastrophe hits your residence.

By taking a few precautionary measures and planning for a worst case scenario, you can be better prepared financially if a natural disaster strikes you and your family.

## FINANCE / MEMBERSHIP

Our membership renewal rate has stalled at 271 for 62.9% Please send in your renewal as soon as you receive your second renewal notice. Remember that you may have sent in your renewal and still get another renewal notice because you missed the cut-off date. The last cut-off was September 13th which means your renewal had to be processed at Legion HQ in Indianapolis before that date. The renewal notices are produced automatically and mailed to you. After the cut-off date, National HQ automatically mails it to you. By renewing early you can help keep the renewal rate from being raised because of the postage increase.

If you are receiving prescriptions from Express Scripts / Tricare, you should be aware that Scripts will cease dealing with Walgreens. Some pharmacies that will continue filling prescriptions are Fred Meyer on Tenney Road, Legacy Salmon Creek, Albertsons on 20th Ave., Target in Hazel Dell, Vancouver Clinic on 139th St. and Wal-Mart on Hwy 99. This is not a complete list. For other pharmacies go to <https://member.express-scripts.com> and set up an account.

Next time you go to a Washington Lottery Sales place, purchase some Hometown Heroes Raffle tickets. They are \$10.00 each. The proceeds benefit the Veterans Innovations Program in our state. The money supports returning veterans and their families. Only 300,000 tickets will be sold, with the winning tickets drawn on Veterans Day. 24 tickets will be worth \$50,000.00.
